

SuperSport Predictor: Beyond the 90 Minutes Competition

Terms and Conditions for participation

1. Introduction

1.1 These rules govern the SuperSport Predictor: Beyond the 90 Minutes Competition (“**Competition**”) conducted by MultiChoice Group and its affiliates across participating countries (“MultiChoice”, “we”, “us”).

1.2 By participating in the Competition, you agree that these rules read together with the [Standard Terms and Conditions](#) will apply to you.

1.3 The Competition will run from **00:00 on 25 May 2026 to 23:59 on 31 July 2026** (“**Competition Period**”).

2. Eligibility

2.1 To participate in the Competition, you must:

- Reside in one of the participating countries. The list of participating countries is included as Annexure A below; and
- Be an active **DStv or GOtv subscriber** during the Competition Period.

2.2 Disconnected subscribers may play and accumulate points but will **only qualify for prizes upon reconnecting their subscription during the Competition Period**.

3. How to Participate

3.1 Participants may access the SuperSport Predictor Game Hub (“**Gaming Portal**”) via any of the following entry points:

- MyDStv App / MyGOtv App - Banners
- SuperSport App - Banners
- SuperSport website - Banners
- Scanning QR codes displayed on promotional materials, including web banners, DStv and GOtv interfaces, and on-screen TV placements. Access via QR code is subject to device compatibility and availability of a camera-enabled smartphone.

3.2 Upon accessing the Gaming Portal, participants shall:

- Register and/or log in to the Gaming Portal
- Play available games and challenges

4. Game Play

4.1 Available games include:

- Predictor games (match outcomes, scores, tournament progression)
- Trivia and quiz games
- Instant play games
- Daily, tournament, and milestone challenges

4.2 Participants earn **Game Points**, awarded immediately after game play. Game Points shall be awarded in accordance with the criteria below:

5. Additional points

5.1 Game Points shall be accumulated together with the points detailed below ("**Additional Points**") to arrive at the total points ("**Total Points**").

5.2 The Total Points determine leaderboard rankings.

5.3 Additional points shall be awarded based on the criteria below:

5.3.1 A maximum of 240 points for login streaks into the Gaming Portal. There are assigned days when login is rewarded. Should the subscriber fail to login on an assigned day, the streak resets to zero and the subscriber must reach the level they were at previously/ before losing points, in order to qualify for additional points.

5.3.2 Five (5) points for inviting a friend to register onto the Gaming Portal and participate in the Competition. A subscriber shall indicate the email addresses of referred friends and can earn up to a maximum of 50 points for ten (10) friends; and/or

5.3.3 A maximum of 500 points earned for watching specific matches on DStv / GOtv stream. Up to 20 hours of viewing will earn a subscriber 100 points. Between 20 to 60 hours of viewing will earn a subscriber 250 points and more than 60 hours of viewing will earn a subscriber 500 points.

5.3.4 A maximum of 100 points earned for QR Code scanning during live match on DStv / GOtv stream (5 points each for a maximum of 20 scans).

5.3.5 We reserve the right to modify the points structure, including Additional Points criteria and allocations, at any time without prior notice.

6. Prizes

6.1 In-Country Prizes (Applicable to only 14 markets)

The top three (3) participants in each country (based on Total Points) will receive:

- **1st** **Prize:**
3 months subscription to the **highest available package on their platform (DStv or GOtv)** at no cost
- **2nd** **Prize:**
2 months subscription to the **highest available package on their platform (DStv or GOtv)** at no cost
- **3rd** **Prize:**
1 month subscription to the **highest available package on their platform (DStv or GOtv)** at no cost

Clarification:

- DStv subscribers will receive the highest-tier DStv package available in their country
- GOtv subscribers will receive the highest-tier GOtv package available in their country

6.2 Pan-African Leaderboard Prizes (Applicable to all markets excluding Angola and Mozambique)

6.2.1 All eligible participants will also automatically compete on a **Pan-African leaderboard** across all participating countries.

6.2.2 The top three (3) participants across all countries will receive:

- **1st Prize:** Smart TV
- **2nd Prize:** Smartphone (iPhone or equivalent)
- **3rd Prize:** Android Tablet

7. Winner Selection & Notification

7.1 Winners are determined based on highest Total Points landing them on the Top 3 positions of the leaderboard.

7.2 Winners will be contacted using their registered details.

7.3 Failure to claim prizes within the stipulated time will result in forfeiture.

8. General Prize Conditions

8.1 Prizes:

- Are not transferable
- Cannot be exchanged for cash or any other item
- May be substituted with items of equal or greater value at MultiChoice's discretion
