

## SuperSport Predictor Premier League

### Competition

1. These are rules for the SuperSport Predictor Premier League Competition ("**Competition**") conducted by the MultiChoice Group and its affiliates ("**MultiChoice**"). By participating in the Competition, you agree that these rules, read together with the [Standard Terms and Conditions](#) ("**Terms and Conditions**") will apply to you.
2. The Competition will run from 00:00 hours on **1 September 2026** to 23:59 hours on **30 May 2027** ("**Competition Period**"), subject to the market-specific participation and Competition periods applicable to **Kenya and Tanzania as set out in clause 8A below**.

### Eligibility

3. To participate in the Competition you must, during the Competition period, reside in one of the participating countries in **Annexure A** below.
- 3.1 Participants under the age of 18 may participate in the Competition and earn points; however, **only participants who are 18 years of age or older at the time of prize allocation will be eligible to win or receive any prize**. The Promoter reserves the right to verify the age of any prize winner, and any participant who does not meet the age requirement will forfeit their prize.

### Competition rules

4. Eligible participants may participate in the Competition by playing games on the SuperSport Predictor portal ("**Predictor Portal**").
5. Eligible participants shall be required to register and/or log into the Predictor Portal. The Predictor Portal is accessible:
  - 5.1 via banners on myDStv App, myGOtv App, the SuperSport App or the SuperSport website;  
or
  - 5.2 through scanning QR codes displayed on promotional materials, including web banners, DStv and GOtv interfaces. Access via QR code is subject to device compatibility and availability of a camera-enabled smartphone.
6. The Competition is **skill-based**. Its outcome is determined by the participant's knowledge, ability and performance. It **does not involve betting or gambling**.

7. The games on the Predictor Portal may include:
- 7.1 Premier League match predictions – participants may predict the outcome of **eligible** Premier League matches throughout the Competition Period. The eligible matches shall be indicated on the Predictor Portal.
  - 7.2 Monthly streaks – participants may earn points by logging in and maintaining eligible monthly streaks as detailed on the Predictor Portal.
  - 7.3 Monthly challenges – participants may participate in monthly challenges and earn points for completing qualifying activities or achieving the applicable challenge objective.
  - 7.4 Premier League African player of the month poll – participants may participate in the monthly poll to vote for the Premier League African player of the month. The poll will be open for 72 hours during each applicable month.
  - 7.5 Instant play games – participants may participate in various instant games made available on the Predictor Portal. These games are primarily intended for engagement and entertainment and may not necessarily earn points for every play. Points shall only be awarded where an instant play game forms part of an applicable challenge or qualifying Competition activity.
8. MultiChoice reserves the right to modify the games, game mechanics and/or points structure at any time. Any changes made by MultiChoice will not retrospectively affect points already validly earned by participants.

#### 8A. Kenya and Tanzania – Market-Specific Competition Period

- Participants accessing the Predictor Portal from **Kenya or Tanzania** may participate in the SuperSport Predictor from **1 September 2026** and may make predictions and participate in eligible engagement activities that allow them to earn and accumulate points.
- From **1 September 2026 to 28 February 2027**, participation by Participants in Kenya and Tanzania will be for **engagement and points accumulation purposes only**. During this period, Participants in Kenya and Tanzania will not participate in, or be displayed on, the Monthly Leaderboard and will not be eligible for any Monthly Leaderboard prize.
- Points validly earned by Participants in Kenya and Tanzania during the period from **1 September 2026 to 28 February 2027** will be retained and carried forward and will contribute to the Participant's cumulative points on the **Season Leaderboard** once the Competition Period commences, subject to these Terms and Conditions.

- The Competition for Participants in Kenya and Tanzania will **commence on 1 March 2027 and will run until 31 May 2027**, being a period of **90 days** ("**Kenya and Tanzania Competition Period**").
- From **1 March 2027 to 31 May 2027**, Participants in Kenya and Tanzania will be eligible to participate in the Competition and the applicable prize mechanics, including the **Monthly Leaderboard and Season Leaderboard**, subject to these Terms and Conditions and the applicable eligibility requirements.
- During the Kenya and Tanzania Competition Period, the **Monthly Leaderboard** will operate in accordance with the Competition mechanics set out in clause 9.1. The Monthly Leaderboard will **reset at the beginning of each month**, and a Participant's position on the Monthly Leaderboard will be determined solely by the **points earned during that applicable month**.
- Points earned during each month of the Kenya and Tanzania Competition Period will not be lost when the Monthly Leaderboard resets. Instead, such points will be added to the Participant's **cumulative Season Leaderboard points**, together with all valid points accumulated by the Participant from **1 September 2026 onwards**.
- The **Season Leaderboard** will therefore track the Participant's cumulative points from **1 September 2026 through 31 May 2027**, and points accumulated prior to 1 March 2027 will carry forward and remain valid for purposes of the Season Leaderboard.
- For the avoidance of doubt, Participants in Kenya and Tanzania will only become eligible for **Competition prizes**, including Monthly Leaderboard prizes and Season Leaderboard prizes, during the **90-day Kenya and Tanzania Competition Period from 1 March 2027 to 31 May 2027**. Participation and points accumulation from 1 September 2026 to 28 February 2027 does not, in itself, create eligibility for any prize.

## Prizes

9. The prizes shall consist of:

### 9.1 Monthly leaderboard prizes

- There will be a Monthly Leaderboard, which will operate for the respective months of the Competition Period, **subject to the market-specific provisions applicable to Kenya and Tanzania set out in clause 8A**.
- Points earned during each applicable month will determine a Participant's position on the Monthly Leaderboard. **For Kenya and Tanzania, the Monthly Leaderboard will only operate from 1 March 2027 to 31 May 2027**, and only points earned during the applicable month will

determine the Participant's position on that month's Monthly Leaderboard.

- At the end of each applicable month, the Participant ranked #1 on the Monthly Leaderboard will be declared the monthly winner and will receive one (1) smartphone of a model determined by MultiChoice.
- At the start of each new month, the Monthly Leaderboard will reset to allow eligible Participants to compete for that month's prize.
- Points earned during each month will not be lost when the Monthly Leaderboard resets. Instead, these points will be carried forward and added to each Participant's cumulative points on the Season Leaderboard.
- Tie-Breaker: In the event that two or more Participants achieve the same highest score on the Monthly Leaderboard, the Participant who reaches the tied score first, based on the recorded date and time on the Platform, will be ranked higher and will be declared the winner of the Monthly Leaderboard prize. The Promoter's records of the date and time on which the relevant score was achieved will be final and binding.

## **9.2. Season leaderboard**

- In addition to the monthly leaderboard, there will be a season leaderboard, which will track participants' cumulative points throughout the Competition Period.
- The season leaderboard will include all qualifying points carried forward from the monthly leaderboards, as well as additional points earned through participation in the African Player of the Month voting poll.
- Participants will earn points for participating in each African Player of the Month voting round, with additional points awarded where applicable, based on the participant's selected player and the outcome of the poll.
- Points earned on the season leaderboard will accumulate throughout the Competition Period and will not reset each month.

- At the end of the Competition Period, the top twenty (20) participants on the season leaderboard will each receive one (1) smartphone of a model determined by MultiChoice.
- The participant ranked #1 on the season leaderboard will, in addition to winning a smartphone, also win the season experience, subject to having participated in a minimum of five (5) African Player of the Month voting rounds during the Competition Period.
- If the participant ranked #1 has not participated in at least five (5) voting rounds, the season VIP experience will be awarded to the highest-ranked eligible participant who has met the minimum voting participation requirement.
- Tie-Breaker: In the event that two or more Participants achieve the same highest score on the Seasonal Leaderboard at the end of the Campaign Period, the Participant who reaches the tied score first, based on the recorded date and time on the Platform, will be ranked higher and will be declared the winner. The Promoter's records of the date and time on which the relevant score was achieved will be final and binding.

#### **Prize acceptance and other terms**

10. Prizes are not transferable and may not be deferred, changed or exchanged for cash or any other item. MultiChoice reserves the right to replace the prize with an alternative prize of equal or higher value if circumstances beyond MultiChoice make it necessary to do so.
11. Prize winners will be notified by means of the contact details provided.
12. If the prize is not collected by the winner within the period indicated by MultiChoice, the prize shall be forfeited.
13. Participants who accept a prize agree to be part of related promotional activity(ies), upon MultiChoice's reasonable request. Such participants consent to the use by MultiChoice of their voice, image, photograph and name for publicity purposes in advertising, marketing or promotional material, without additional compensation.
14. MultiChoice will process any personal information supplied by participants who participate in this Competition in line with its data [Privacy Notice](#), and in accordance with applicable Data Privacy legislation. Participants hereby agree to the processing of their personal information to enable them to participate in the Competition, and should the participant be a winner of the Competition, to enable MultiChoice to contact them regarding the prize and for purposes outlined in paragraph 13.

15. MultiChoice shall not be liable for any failure to comply with its obligations where the failure is caused by circumstances outside its reasonable control.
16. The rule of construction that the Terms and Conditions will be interpreted against the party responsible for the drafting or preparation of this document and the Terms and Conditions will not apply.
17. MultiChoice may cede, assign or novate any or all of its rights and/or all of its obligations set out herein and/or in the Terms and Conditions to any person or entity without notice to you.
18. MultiChoice reserves the right to suspend or stop your participation in the Competition if you are involved in fraud or manipulation of the process.
19. The failure by MultiChoice to enforce any of the rights or provisions of the Competition or the Terms and Conditions will not be deemed to be a waiver of such right or provision.
